### **Factor VIII**

Please ensure that all products removed from the Haemophilia Centre fridge are recorded on the forms on clinic bench e.g. patient details, product name and vial size etc.

### **Guidelines for Recombinant Clotting Factor**

- Do Not confuse **Recombinant Factor** with **Plasma** derived Factor concentrates which is supplied by Blood Bank.
- The Haemophilia Centre supplies and manages the treatment products for Bleeding Disorder patients at home or hospital.

  - After hours call Ward 27B or the Haematology Registrar on call.
- Check the name of the product that the patient receives. Each patient is prescribed a specific 'brand' of Factor concentrate. This is stated in the patient's clinical notes on RCP.
- They must only receive this brand unless told otherwise by the Haemophilia team. There is a potential for a reaction to occur with a change of brand.
- The prescribing doctor should prescribe the clotting factor by brand name. There are varying sizes. 250units, 500u and 1000u, 1500u and 2000units.
- These products are expensive, please don't waste any. When prescribing, round up or down to next vial size.
- Each product comes with the correct diluent and mixing devices.
- There are two Recombinant Factor FVII products: **Advate** (Takeda – short-acting product) and **Adynovate** (Takeda - long acting)
- There are two Recombinant FIX products: **Rixubis** (Takeda short-acting product) and Alprolix (Sanofi long-acting product)
- There is one brand of Recombinant FVIIa: **Novoseven** (Novo-Nordisk)
- All are kept in the Haemophilia Centre fridge or on clinic bench.
- A supply of Novoseven is also kept in Pharmacy for **Non Haemophilia Patients**.
- The Clinical Nurse Managers have access to the Haemophilia Centre fridge after hours. Please leave details of what has been taken, along with patients name and hospital number, as each vial needs to be accounted for.
